## **IMPORTANT**

## **MEMBERSHIP**

- 1. Members of the Association shall be **manufacturers** or **component suppliers** in Australia of window furnishings designated by the Association from time to time in general meeting. Such manufacturers to:
  - (a) occupy or use premises properly registered in accordance with relevant Australian legislation on registration of individual workplaces;
  - (b) be registered as a taxpayer in accordance with the relevant Commonwealth legislation;
  - (c) occupy or use premises which are readily identifiable and accessible from the nearest street to the satisfaction of the Directors;
  - (d) have at least 3 years practical experience in the industry, or alternatively have trained staff sufficient to ensure quality workmanship;
  - (e) carry Public Liability Insurance;
  - (f) provide three trading references to the Association.
- 2. Any such manufacturer or supplier in Australia may make application to become a member of the Association. The application shall be made in writing to the Secretary of the Association and may be required to be in a specified form. The applicant may be admitted to membership upon due election as such at any Directors meeting of the Association by a unanimous vote of Directors present and upon payment of contribution for the current year and the prescribed entrance fee, if any.
- 3. By making application for membership of the Association, the applicant agrees:
  - (a) to pay promptly all contributions and/or assessments as they become due;
  - (b) to be represented when possible at all meetings and to co-operate with the Association in all matters of general interest to the trade;
  - (c) to be bound by the Constitution and Rules of the Association.
